Please include your Penalty Charge Notice number, vehicle registration number and your address so that we can investigate your case and reply to you.

If you challenge this Penalty Charge Notice within 14 days (from the served on date), we will re-offer the discount period if your challenge is rejected. All cases will be considered and we will send a written response by post usually within 7 working days.

If the penalty charge is not paid or challenged

If the Penalty Charge is not paid on or before the end of the 28 day period as specified on the front of this notice or successfully challenged, the council may serve a Notice to Owner (NtO) on the registered owner/keeper requiring full payment of the Penalty Charge. The owner/keeper can then use the Notice to Owner to make a representation to the council and may appeal to an independent adjudicator if the representation is rejected by the council. The Notice to Owner will contain instructions for doing this. If you challenge this PCN but the Council issues a NtO anyway, the owner must follow the instructions on the NtO.
