- (2) In relation to the morning on which Summertime begins, paragraph (1) of this condition shall have effect with the substitution of references to 02:00 hours in the morning for references to 01:00 hours in the morning.
- (3) On New Year's Eve the permitted hours shall extend through from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day.
