

# NOTICE OF ELECTION

## Election of the Police and Crime Commissioner for the Staffordshire Police Area

1. Nomination papers must be delivered to the Police Area Returning Officer at the Elections Office, Civic Centre, Glebe Street, Stoke-on-Trent, ST4 1RG on any working day after the date of this notice, during hours of 10am and 4pm **but no later than 4pm on Thursday 07 April 2016.**
2. Nomination papers may be obtained from the offices of the Police Area Returning Officer, at the place and times stated above.
3. If the election is contested the poll will take place on Thursday 05 May 2016.
4. A deposit of £5,000 must be paid for each candidate by the deadline for delivery of nominations either in legal tender, by banker's draft.
5. Applications to be included in the register of electors must reach the relevant Electoral Registration Officer by Monday 18 April 2016, if they are to be effective for the election.
6. Applications, amendments or cancellations of postal votes must reach the relevant Electoral Registration Officer by 5pm on Tuesday 19 April 2016.
7. Applications to vote by proxy at this election must reach the relevant Electoral Registration Officer by 5pm on Tuesday 26 April 2016.
8. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Elections Office, Civic Centre, Glebe Street, Stoke-on-Trent, ST4 1RG by 5 pm. on Thursday 5 May 2016.

The physical incapacity must have occurred after 5 pm on Tuesday 26th April 2016.

To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday 26th April 2016.
