a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

Digital CCTV will be installed at the premises, will display the correct time and date and will record for 31 days, the system will make recording at all times that the premises are open to the public and will be made available to the police or other responsible authorities on reasonable request. A staff member who is familiar with the CCTV system will be available within an hour if requested by the police. This staff member will be able to show and burn to disk for the police any recent footage. There will be Signage indicating that CCTV is in operation

The DPS will be an active member of the local pub watch whilst such exists

b) The prevention of crime and disorder

A minimum of 2 SIA registered door supervisors will be on duty from 23:00 on a Friday and Saturdays night and at any time that the premises trades beyond midnight. An additional number will be deployed appropriate to any risk assessment. A record of the supervisors will be available with Door supervisor name and date of birth; their SIA security number, the time that they start/finish. The register will include the Door supervisors' company name, address and contact number. The door supervisors will wear Yellow high visibility jackets and enable the clear display of SIA authority

During the absence of the DPS a designated duty manager will be on site during key trading hours

A zero drugs policy will be implemented

c) Public safety

Regular toilet checks will be implemented and the results recorded

All accidents/incident will be recorded in the incident log and will be available for inspection
Weekly H&S checks will be implemented, including fire safety and the results recorded and will be available for inspection

Bi annual audits will be implemented including risk assessments and the fire risk assessment and recorded

Emergency lights and fire alarm will be tested weekly and the results recorded

fire doors shall not be held open other than by an approved device

any persons carrying opened or sealed bottles will not be allowed to enter or remain on the premises at any time that the premises are open to the public

Staff shall be trained on induction on Fire Safety, Challenge 25 and the non service of drunks and refresher training undertaken at regular intervals

Online training will also be implemented

During the performance of regulated entertainment all windows and doors shall remain closed except for entrance or exit from the premises

A sign will be located at the exit(s) requesting that customers leaving the premises do so quietly and with consideration to the neighbours
