Tamworth Assembly Rooms is a entertainment venue, hosting a wide range of events from live music ,conferences, comedy, pantomime, theatre, drama and exhibitions. It has been the providing arts and entertainment in the town for 130 years.

It is currently undergoing a refurbishment and as a result has extended and increased the footprint of the venue, creating a new 'multi use' space which will be used as a bar in the evening for ticketed performances and for smaller scale events and meetings during the daytime. The possible seated capacity of the venue will increase from 349 to 363.

To help promote the 4 licensing objectives we have implemented venue procedures, management controls and the required staff training to ensure all staff are aware of the venue licensing.

Particular attention to:

- a. No selling of alcohol to underage people (Challenge 25)
- b. No drunk or disorderly behaviour on the premises area will be tolerated
- c. Vigilance in preventing the use and sale of illegal drugs on the premises
- d. No violent or anti-social behaviour on the premises will be tolerated
- e. Safeguarding of vulnerable persons

b) The prevention of crime and disorder

1. CCTV system installed to monitor entrances, exits, and other parts of the premises in order to prevent crime and disorder.
2. All full time staff are SIA security trained in how to deal with aggressive or confrontational behaviour.
3. External security staff will be brought in for certain events to assist in the stewarding of of the customers
3. Any persons deemed too intoxicated will not be served alcohol
4. Venue part of the Tamworth Storewatch scheme
5. Staff trained in licensing awareness

c) Public safety

1. Risk Assessments carried out and reviewed throughout the year.

3. Fire fighting equipment in place and checked weekly
4. Daily pre event Duty Management checks are carried out prior to allowing the public access to the venue.

d) The prevention of public nuisance

1. Main hall fitted with new state of the art acoustic absorption panelling resulting in very low noise spillage.
2. Duty managers and technicians employed by the licensee will ensure that the volume of amplified voices and music are kept at levels which do not give rise to a public nuisance.
3. Deliveries will be undertaken at a reasonable time during the day and will be accessible through our own private loading bay at the rear of the venue, restricting disturbance to surrounding properties.
4. Customers exiting the venue late at night will be encouraged not to stand around talking in the street outside the premises.
5. Any lighting on or outside the premises will be positioned and screened in such a way so as to not cause a disturbance to nearby residents.
6. Adequate waste receptacles for use by customers will be provided within the venue vicinity.
7. The details of any incident of public nuisance arising from the premises will be recorded and reported to venue management to action.

e) The protection of children from harm

3. Any persons under 14 has to be accompanied by an adult whilst on the premises.
4. All staff are Safeguarding trained through Tamworth Borough Council

Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives.  - Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority

concerned, or (ii) the school or (iii) the health care provider for the hospital.

- Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
