Using Google Analytics we collect Internet log information and details of visitor behaviour patterns. We do this to find out how many visitor we have had to the Council's websites. This information does not identify anyone. This analytical tool uses 'cookies', which are text files placed on your computer. You can opt out of being tracked by Google Analytics across all websites by downloading the Google Analytics Opt-out Browser Add-on.

Social Media

Tamworth Borough Council uses social media to gain feedback from residents, tell you about changes in our services or promote new services, events, offers and opportunities. We will also use social media to respond to any comments you have made and send your feedback to the departments it relates to. Our social media sites are open so any comments you have made will be accessible by the general public.

Press and Photography

With your consent, we will use your information to publicise Tamworth Borough Council's events, activities and services through our website, social media and press releases. We may also use it for Tamworth Borough Council publications. We will get consent from you for photography where you are the main photo subject. There may be instances where

photographs are used without consent because you are not the intended subject of the photograph.

Corporate Engagement

With your consent, we will use your information to undertake customer research to help us understand how we can improve our services or to tell you about consultation and engagement events.

Legal Purpose

We will only use your personal information when the law allows us to. Most commonly we will use your personal information under **Consent**. You can remove your consent at any time by contacting Tamworth Borough Council or removing yourself from our social media sites or Google Analytics.

Third Parties we might share information with

The Communications and Press and PR Department shares information publically. If we are sharing your personal information we will limit this to what is necessary.
